

Information about the RSR Client-Level Completeness Report

(This document is based on information provided by HRSA)

What is the Completeness Report?

The *Completeness Report* provides you with information about the completeness of the RSR Client Report data that were submitted. Specifically, it provides information about the number of clients for whom a “known” value was reported, those for whom an “unknown” value was reported, and those for whom “no data” were reported. A “known” value means a value listed in the *RSR Data Dictionary and XML Schema Implementation Guide for the Client-Level Data Report*.

The *Completeness Report* is divided into three sections: Demographics, Services, and Clinical Information.

How Can I Use the Completeness Report?

Grantees and providers can use the “RSR Client-Level Data Completeness Report” to assess and improve the completeness of the data submitted in the RSR. Specifically, the **goal is to have as complete data as possible while minimizing "unknown" responses**. This provides the most accurate picture of funded activities.

How Did You Come Up With The Numbers?

The **Completeness Calculations** (on the following pages) explain how the percentages provided in the *Completeness Report* were calculated. The data came directly from the RSR XML file that your agency submitted.

Definitions:

- **Data Element** – There are 66 client-level data elements in the RSR. Not all data elements need to be reported by all providers. Please review the *Completeness Calculations* for more information about which data elements are required.
- **Total Clients Reported** –Total number of unique clients reported (based on unique eUCIs) with at least one service.
- **Required Clients for this Data Element** – Number of clients for whom the data element is required. Please see the *Completeness Calculations*. Note that some Data Elements do not include all Service Items.
- **Clients with Known Value Reported** – Number of required clients for whom the data element is reported with a value other than “unknown”.
- **Clients with "Unknown Value" Reported** – Number of required clients for whom the data element is reported with an “Unknown” value.
- **Clients with No Value Reported** – Number of required clients for whom nothing is reported for the data element.
