

AIRS and ERA

1. AIRS current version -- 9.0.60 (Released 12/1/23)



- You can find instructions for upgrading and upgrade files at Freshdesk
- If you are having any technical issues while trying to upgrade or after upgrading, please contact NetSmart <u>SUPPORTAIRS@ntst.com</u>
- This version of AIRS is required for the RSR submission
- This version of AIRS is required to have access to the new SDOH mapping required for some initiatives.
- Please set aside some time to get your AIRS system upgraded in a timely manner.
- Please review and share the Release Notes as appropriate
- You must be upgraded to AIRS Version 9.0.60 or you will not be able to upgrade to future versions
- A patch has gone out to update certain services to make them RSR eligible. Agencies who need the patch will be contacted.
- 2. The Upcoming AIRS Upgrade
 - Race and ethnicity variables will be modified based on feedback received from our monthly prevention call.
 - Ethnicity will be filled out first and if Hispanic ethnicity is selected, the race variable will offer a "Chose not to respond" or "Other" option
 - The "Details" for each race category will change to allow you to check as many subcategories as applicable.
 - The HIV risk assessment will be modified to change some required fields to optional
 - This is to facilitate data entry and to decrease use of the risk assessment as a "checklist". Programs should ask open ended questions and document in the risk assessment as appropriate
 - The HCV risk assessment will be trimmed down and some of the fields will be discontinued.
 - Utilities will be upgrades to take away the requirement for passwords to be exactly 10 characters.
 - Updated data collection forms are posted on AIRSNY.org when AIRS upgrades go out.
- 3. ERA current version 1.0.9.8
 - The Data Unit is available to assist you or your IT department with installing or upgrading ERA. Please email: <u>PreventionDataUnit@health.ny.gov</u> for assistance
 - A new version of ERA is underway and stay tuned for a release date!
- 4. AIRS Training
 - AIRS training documentation and videos can be found at <u>www.airsny.org</u>
 - Online training occurs monthly, and it is recommended to sign up at <u>www.airsny.org</u> to receive notifications of these trainings
- 5. The future of AIRS is underway
 - At this stage, there are no solid dates we can give you for the timeline of this project.

- 1. AIRS 9.0.60 allows you to be mapped for the new Social Determinants of Health Service Category. You will not be able to have the Social Determinants of Health service category if you are not upgrades to AIRS 9.0.60!
- 2. Agencies with CHI and YMSM contracts should look forward to receiving planning files with the new Social Determinants of Health service category.
- 3. The encounter will also be called Social Determinants of Health and there will be a variety of services available that tie back to the SDOH assessment.

Backing Up

- 1. Friendly reminder to back up your system on a regular basis.
 - If you lose your data and don't have a backup it can take MONTHS to get it back, and it will not be complete
 - Please verify that your backups being run through utilities are being saved to the correct folder and then save them on an encrypted external flash drive as well.
 - Your IT team is responsible for any nightly server backups.
 - Be sure to perform a backup before creating and submitting extracts. This way the backup information will be reflected in the data being sent to us in the extracts.
 - Your RCMR will tell you when your last recorded backup was:
